10. Board Members/Comments or Concerns: Harrell stated he is attempting to coordinate with Mayor Tarkington to be able to attend next meeting.

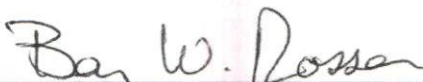
11. Adjournment: A motion was made by Bryning and seconded by Harrell to adjourn. The motion was approved with the following votes: all aye.
